6. City update reports

- Reedsport decided on check-out software to use. Also willing to revisit county wide system once LFTF comes up with their recommendation.
- Upcoming Canyonville City Council meeting. Discussing collaboration with the school district. Representative is hopeful there will be something signed in the near future.
- Sutherlin-Library open same hours solely on volunteers.
 Formed a 501c3 locally. City has formed agreement with School District and they will move in over the summer months.
- MC-Large group of volunteers, 50+. Formed a 501c3 and taking in donations and fundraising. Plan is to at least have a reading room.
- Winston-Meeting with library committee soon and will take to city council. Concerned with number of volunteers.
 Looking toward check-out IGA if they can get enough volunteers. Census is they would like to do something, but resources are an issue.
- Oakland-Filed 501c3 approx. 1 month ago. In communication with school district, however, superintendent turnover is an issue. Working on donations through friends of the library. Good patron attendance even though the doors are only open on Fridays.
- Drain-Scheduled 2 community meetings as they haven't gotten a lot of feedback from community. No decision regarding future IGA at this point. Meetings will be educational as far as donations and volunteers. This will drive city councils decision on IGA. Their Friends of the Library is a 501c3.
- Yoncalla- Signed IGA. Will be in front of the BOC at the meeting.
- Glendale- Close to IGA signed. Non-profit collected enough to file the 501c3. Glendale parade float 4th of July announcing their grand opening. Shortage of volunteers and money.

7. Comment/Questions-Commissioner Leif

- Check out IGA disseminated to all task force members. Any cities interested in this, just needs to resubmit the new IGA to the county.
- Met with Roseburg School District Superintendent this week.
 They are unable to help at this juncture due to budgetary restrictions, but possible collaboration in the future.
- B. Bell suggested the importance of hiring a part-time employee to rally the volunteers at city libraries.
