14. COMMISSIONERS COMMENTS

Commissioner Kress responded to Ms. Larson's comments and stated as an independent voice he was asked by a citizen to check into the concerns. He contacted Keith at Department of Forestry and was told his opinion was there was no need to do a notification and the hazard trees were removed in accordance to rules and regulations. He also is making sure the Chief Financial Officer for the County monitors where the money goes. Commissioner Kress described the selection and criteria of Wolf Advisory Board members.

Commissioner Boice stated the Parks Director's job and whose primary interest is to maintain the parks as safely and as cost effectively as he can for the using public and he is doing his job. Commissioner Boice appreciates the respectful comments made today, but unfortunately this is not the case with all the people. He showed a negative sign being posted and stated this type of behavior does not help improve relationships between us and the disc golf community. Rocky asked Keith Waldron at ODF for a recap of the timeline of the situation and added the Parks Director wants to do things the right way. The trees were a risk and needed to be removed. Commissioner Boice hopes relationships can be mended with the disc golf community to have a collaborative working relationship moving forward.

Commissioner Freeman commented on a large disc golf tournament held years ago at Whistler's Bend. The safety of those people in our parks is very important. Previously, the Park's Director position was being managed by the Land Department Director performing both duties. The Board sought a full-time Parks Director who was hired for his expertise managing parks. Douglas County has one of the most diverse parks systems of any county in the State of Oregon. Rocky Houston does a fantastic job managing all of the different needs and uses. Commissioner Freeman encouraged Mr. Houston to work closely with the disc golf organization. He added we are not unique in dealing with hazards. Commissioner Freeman stated he is appreciative of the Parks Department and Rocky for thinking about safety.
